FINAL PLATS:

Washington Township - Williams and Streibel Property

Mr. Weissman stated that This is a replat to slightly alter the dimensions of two platted lots in order to better accommodate the construction that has occurred on the lots. Lot #1 will increase in area by approximately .0402 acres, and Lot #2 will decrease by approximately .0402 acres. The

total acreage of both lots is 1.415 acres, located at the intersection of Viewpoint Drive and Folkstone Road. Access both lots will be from Viewpoint Drive. No public infrastructure is necessitated by this replat, however, the developer will need alter the course of a utility easement that is shown on the Record Plan to remove the easement from a building set back area, or provide documentation indicating that the easement is acceptable as shown.

Mr. Weissman stated the County Engineer stated that the developer will need to add or document the proper utility easement for Lot #1. He stated that County Water Services and Township Zoning had no major issues.

Mr. Weissman stated that staff recommends approval of the Record Plan, subject to the addition of the necessary easement data.

On a motion by Ms. Rice and seconded by Mr. Sauer it was moved to approve the Washington Township – Williams and Streibel Property Replat.
